### Two-Person Team Scramble

Thursday, June 25, 2026

#### I. ELIGIBILITY

- Open to all The Orchard lady members, spouses and dependents in good standing and their invited lady guests with an established NGAP WHS handicap index as of June 1, 2026.
- Those without established NGAP WHS handicaps may still join but will be given a zero (0) handicap. They are encouraged to register to NGAP WHS to qualify for other tournaments.

#### II. REGISTRATION

- Opens from **June 1, Monday to June 16, Tuesday.**
- Only **60 teams** will be accommodated.
- May be done via phone call at 0917-8007273 / 0917- 8846810 / (02) 8989 – 2000 locals 2241 and 42 or in-person at the Golf Office.
- Registration will be accepted until **June 18, Thursday at 5:00PM.**

#### III. ENTRY FEE/RAFFLE/AWARDING

- **P1,000.00** for members & dependents
- **P4,000** for guests
- Inclusive of food and raffle during the awarding
- May be settled on the day of the tournament through the player's folio
- Presence is required for the raffle draw
- Awarding will be held right after the game at the **Conrado Benitez Hall.**

#### IV. CANCELLATION POLICY

- The following cancellation penalties per player shall apply:
  - › **No penalty** – for cancellations made **on/or before June 17, Wednesday**
  - › **P500.00** – for cancellations made **from June 18 to 21 at 5:00 PM**
  - › **P1,000.00** – for cancellations made **beyond 5:00 PM on June 21.**

#### V. FORMAT

- 18-Hole 2-Person Team Scramble (Full Scramble Format)
- Lady-lady partners (member-member or member-guest)

#### Mechanics of Play:

Each player plays from the teeing ground, partners then select the ball which where/ball to play for their next shot. **The player of the selected ball must play his/her ball as it lies**, then his/her partner must place his/her ball within one (1) scorecard length no nearer the hole and on the same condition of



the selected ball. Same condition means if the chosen ball is in the "general area", the partner must place his ball also in the "general area". If the ball is on the bunker, it should be placed on the same bunker also, etc.

Order of play for the shot will be on the side's discretion but the selected ball cannot be lifted or marked. If the selected ball shall be played first, it is mandatory to mark the point on the ground for the one scorecard length from the selected ball where the side intends to place the partner's ball. This procedure must be followed until they reached the putting green. On the putting green, each partner must place his ball within one (1) putter head length from the selected ball no nearer the hole.

*Note: Rule 6.3a, "The player must hole out with the same ball played from the teeing area and may change balls between the play of two holes., except when that ball is lost or comes to rest out of bounds, or the player substitutes another ball (whether or not allowed to do so).*

#### **VI. COURSE/TEE TIME/TEE:**

- Palmer Course – 6:30 AM Shotgun start

#### **VII. HANDICAP INDEX & HANDICAP:**

- Handicap index – The participant's NGAP WHS handicap index as of June 1, 2026, shall be used.
- Team handicap will be 35% of the low handicap player plus 15% of the high handicap player

#### **VIII. CLASSIFICATION**

Member-member partners shall be divided into two (2) divisions based on their team handicaps. Member-guest partners in one division.

- Division I – first 50% of the member-member partners
- Division II – second 50%
- Division III – Member-guest partners

#### **IX. STARTING TEES**

- Red Tees for all the participants

#### **X. AWARDS**

- Over-all Team Champion
- Division Champions and Runners-up

#### **XI. TIES**

- Ties shall be settled based on the team net scores:
  - a) last 9-hole totals (10 -18);
  - b) last 6-hole, (13 -18);
  - c) last 3-hole totals (16 -18);
  - d) countback from the 18<sup>th</sup> hole



**XII. SPECIAL TOURNAMENT RULE TO SPEED UP PLAY**

- The maximum score in any hole is nine (9), including penalties.
- "Gimme" Putt – Any ball **lying within or above the line** of the 24-inch gimme circle shall be considered holed on the player's next stroke. The player must pick up his ball and add one stroke to his last stroke's score.

**XIII. RULES OF GOLF:**

- Play shall be governed by the latest Rules of Golf published by R&A Rules Limited and the Club's Local Rules.

**XIV. COMMITTEE:**

- The Committee reserves the right to make any changes in the Terms of Competition (ToC), if it deems fit and necessary. Disputes if any, shall be settled by the Tournament Committee, whose decision shall be final.
